3. ಈ ಆದೇಶದ ಉದ್ದೇಶಗಳಾಗಿ ಮೂಲ ವೇತನ ಎಂದರೆ ಸರ್ಕಾರಿ ನೌಕರನು ಧಾರಣ ಮಾಡಿರುವ ಹುದ್ದೆಗೆ ಅನ್ಯಾಂಕಾಗೆ ಮಾಡಿರುವ ಮತ್ತು ಎಫ್‌ಎನ್‌ಜೆಫಿಸಿ ವೇತನ ಶ್ರೇಣಿಗಳಲ್ಲಿ ಪಡೆಯುವ ವೇತನ.

4. ಮೂಲ ವೇತನಕ್ಕೆ ಇನ್ಯಾವುದೇ ಉಪಲಬ್ಧಗಳನ್ನು ಸೇರಿಸತಕ್ಕದ್ದಲ್ಲ.

5. ತುಟ್ಟಿಭ್ರೇಯ ಕಾರಣದಿಂದ ಸಂದಾಯ ಮಾಡಬೇಕಾಗಿರುವ ಐವತ್ತು ಪ್ರೇಸೆ ಹಾಗೂ ಅದಕ್ಕಿಂತ ಹೆಚ್ಚಿನ ಭಿನ್ನಾಂಕಗಳನ್ನು ಮುಂದಿನ ರೂಪಾಯಿಗೆ ಮೊರ್ಚಾಗೋಳಿಸತಕ್ಕದ್ದು ಮತ್ತು ಐವತ್ತು ಪ್ರೇಸೆಗಿಂತ ಕಡಿಮೆ ಇರುವ ಭಿನ್ನಾಂಕಗಳನ್ನು ಕಡೆಗಳಿಸತಕ್ಕದ್ದು.

ORDER NO. FD 22 SRP 2011, BANGALORE, DATED 19th APRIL 2011.

Government are pleased to sanction increase in the rates of Dearness Allowance to Teaching Staff who are on UGC/ICAR/AICTE scales of pay and Judicial Officers on FNJPC pay scales from the existing rate of **45%** to **51%** of the basic pay with effect from **1st January 2011**.

2. The increase in Dearness Allowance admissible under this order is payable in cash until further orders.
3. For the purpose of this order, the term 'Basic Pay' means, the pay drawn by a Government employee in the 2006 revised UGC/ICAR/AICTE and FNJPC scales of pay applicable to the post held by him.
4. Basic Pay shall not include any other emoluments.
5. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
6. The Dearness Allowance will be shown as a distinct element of remuneration and will not be treated as pay for any purpose.

7. Orders relating to increase in Dearness Allowance in respect of Teachers in Polytechnics and Medical Education Department etc., who are on pre-revised AICTE scales of pay will be issued separately.
