Sub:- Revision of the rates of Dearness Allowance to Teaching and equivalent cadre staff on 2016 revised **UGC/ICAR/ AICTE** scales of pay - reg.

PREAMBLE:

In view of the crisis arising out of Covid-19 pandemic, in G.O. dated: 05.05.2020 read at (3) above the State Government as a matter of policy have issued orders freezing the revision of dearness allowance in respect of employees on UGC/ICAR/AICTE/NJPC Scales of Pay for the period 01.01.2020 to 30.06.2021 until further orders. In GOI O.M. dated: 20.07.2021 read at (4) above orders have been issued revising the dearness allowance rates of central government employees for the period 01.01.2020 to 30.06.2021.

Hence, it is considered necessary to revise the dearness allowance rates in respect of serving employees on 2016 Revised UGC/ICAR/AICTE Scales of Pay. Accordingly, the following orders are issued.

GOVERNMENT ORDER NO. FD 19 SRP 2021 BENGALURU, DATED 29TH JULY 2021

Government are pleased to release the additional installments of dearness allowances in respect of employees on 2016 Revised UGC/ICAR/AICTE Scales of Pay for the period 01.01.2020 to 30.06.2021. Hence, the rates of Dearness Allowance of the teaching and equivalent cadre staff on 2016 Revised UGC/ICAR/AICTE Pay Scales shall be revised from the existing 17% to 28% of the revised basic pay with effect from 1st July 2021.

- 2. For the purpose of this order, the term 'Basic Pay' means, the pay drawn by a Government employee in the 2016 Revised UGC/ICAR/AICTE pay applicable to the post held by him.
- 3. These orders will apply to the fulltime employees on UGC/ICAR/AICTE Scales of Pay working in Universities, Government/Aided Educational Institutions, Government Autonomous Institutions etc.
- 4. Basic Pay shall not include any other emoluments.
- 5. The Dearness Allowance admissible under this order is payable in cash until further orders.

- 6. These orders are not applicable to retired employees on UGC/ICAR/AICTE Scales of Pay.
- 7. Separate orders will be issued in respect of judicial officers on NJPC Scales of Pay and pensioners.
- 8. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
- 9. The Dearness Allowance will be shown as a distinct element of remuneration and will not be treated as pay for any purpose.
