## GOVERNMENT ORDER NO. FD 25 SRP 2022 BENGALURU, DATED 9<sup>TH</sup> May 2022

Government are pleased to enhance the rates of dearness allowance in respect of the Judicial Officers on 2006 Revised NJPC Scales of Pay and in respect of retired Judicial Officers from the existing rate of **196% to 203%** of the Basic Pay and Basic Pension as the case may be with effect from **1**<sup>st</sup> **January 2022**.

2. For the purpose of this order, the term 'Basic Pay' means, the pay drawn by the Government servant in the 2006 NJPC Pay Scale applicable to the post held by him.

3. Basic Pay shall not include any other emoluments not classed as pay.

4. The Dearness Allowance admissible under this order is payable in cash until further orders.

5. The payment of arrears of Dearness Allowance will be made after the disbursement of salary for the month of May 2022.

6. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.

7. The Dearness Allowance will be shown as a distinct element of remuneration and will not be treated as pay for any purpose.
