GOVERNMENT ORDER NO. FD 21 SRP 2023 BENGALURU, DATED 26th OCTOBER 2023

Government are pleased to revise the rates of Dearness Allowance payable to the teaching and equivalent cadre staff on 2016 Revised UGC/ICAR/AICTE Pay Scales from the existing 42% to 46% of the revised Basic Pay with effect from 1st July 2023.

- 2. For the purpose of this order, the term 'Basic Pay' means, the pay drawn by a Government employee in the 2016 Revised UGC/ICAR/AICTE pay scale applicable to the post held by him.
- 3. These orders will apply to the fulltime employees on UGC/ICAR/AICTE Scales of Pay working in Universities, Government/Aided Educational Institutions, Government Autonomous Institutions etc.
- 4. Basic Pay shall not include any other emoluments not classed as pay.
- 5. The Dearness Allowance admissible under this order is payable in cash until further orders.
- 6. These orders are not applicable to retired employees on UGC/ ICAR/ AICTE Scales of Pay.

- 7. The payment of arrears of Dearness Allowance shall not be made before the date of disbursement of salary for the month of October 2023.
- 8. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
- 9. The Dearness Allowance will be shown as a distinct element of remuneration and will not be treated as pay for any purpose.
